注：视力障碍运动员除需在**横琴**马拉松官方网站或官方合作APP正常报名外，还需在官方网站下载《视力障碍运动员报名申请表》，填写后连同残疾人证扫描件或照片在9月12日22时前回传至官方联系邮箱(OC@hengqinmarathon.com)。视力障碍运动员须由伴跑运动员全程伴跑。伴跑运动员须为已成功提交报名信息，且与视力障碍运动员报名参赛项目一致的运动员，且须一并进行报备登记。未向组委会报备，擅自参赛所产生的后果，由运动员自行负责。视力障碍运动员与伴跑运动员在报名参赛人员超额后参加统一的报名抽签。任一方逾期未付款或退赛退费的视为主动放弃本次参赛资格，双方参赛资格均不再保留。组委会将与运动员和伴跑运动员进行双向确认。因伴跑运动员未尽陪跑责任导致安全事故（包括产生运动员人身伤害）的，由运动员自行承担。

Notes: The runners with visual impairment must, upon registration via the official website or official cooperative app of Hengqin Marathon, log into the official website, download and complete the Visual Impairment Entrants Application Form, and submit it along with a scanned copy or photo of the runner's disability certificate to the Organizing Committee via email (OC@hengqinmarathon.com) by 22 p.m. on September 12, 2026 (Beijing time). Any runner with visual impairment must have a guide runner throughout the race. The guide runner must be a successfully registered participant competing in the same event and must also complete the required registration and reporting process. The concerned runners shall be held solely responsible for any consequences arising from their unauthorized participation without the above-mentioned steps. If total entries exceed the quota, unselected entrants with visual impairment and their guide runners need to join the lottery. Should either entrant with visual impairment or guide runner fails to make the payment within the designated period, both parties will be deemed to have automatically waived their entry qualifications, which will not be retained. The Organizing Committee confirm the waiver with both parties. If a safety incident (including personal injury to the runner) occurs due to the guide runner's failure to fulfill their duties, the concerned runners shall bear full responsibility.
